ARTICLES OF ORGANIZATION

OF

SERVICES TO AGRICULTURE I, L.L.C.

The undersigned, Michael Stuart, President of FFVA-Aim, Inc., acting as Manager of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby forms a Limited Liability Company for profit under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

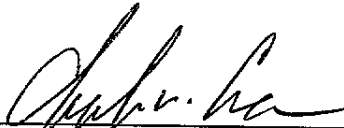
