**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
FOR
RTT STORAGE, L.L.C.**

The undersigned, Margaret Schaffler, a member of RTT STORAGE, L.L.C., a Florida limited liability company (the "Company"), hereby presents these Amended and Restated Articles of Organization pursuant to the provisions of Section 608.411, Florida Statutes. These Amended and Restated Articles of Organization have been duly adopted by the members of the Company and shall be effective as of October 3, 2013.

FIRST: The Company's Articles of Organization were filed on May 24, 1999, with the Florida Department of State and assigned document number L99000003033.

SECOND: The Articles of Organization are superseded in their entirety by the provisions of these Amended and Restated Articles of Organization.

THIRD: The Company's Amended and Restated Articles of Organization are set forth in their entirety as follows:

ARTICLE I - NAME

The name of this Limited Liability Company shall be:

This limited liability company is referred to in these Amended and Restated Articles of Organization as the "Company."

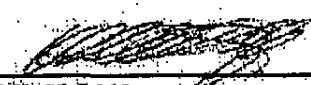
