FOURTH: The Company is hereby dissolved because of lack of sufficient business to continue to be a viable and profitable operation.


FIFTH: All debts, obligations, and liabilities of the LLC have been paid or discharged, or adequate provision has been made therefor pursuant to Section 608.4421.
