**ARTICLE I - Name**

The name of the limited liability company is **ALOMA PARK, L.L.C.**

**ARTICLE II - Address**

**ARTICLE III - Duration**

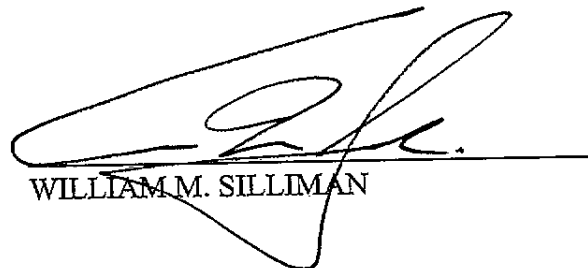

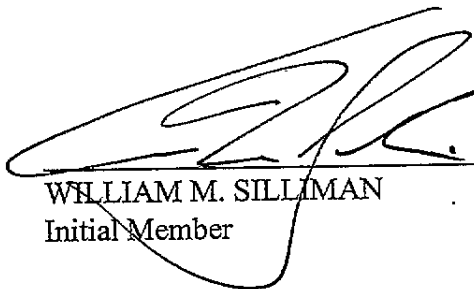
