**ARTICLES OF ORGANIZATION

1. NAME.

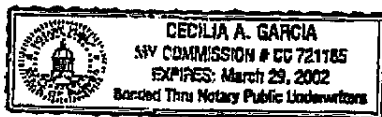


