**ARTICLES OF ORGANIZATION
OF
LJ ENTERPRISES MANAGEMENT, LLC**

ARTICLE I - Name

The name of the Limited Liability Company is "LJ ENTERPRISES MANAGEMENT, LLC" (the "Company").

ARTICLE II - Address


