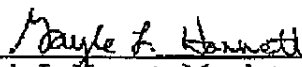

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF J&H DEVELOPMENT I, LLC  
(a Florida limited liability company)**

1. The date of filing of the Articles of Organization was June 3, 1999.
