## ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

### ARTICLE I: NAME

The name of the Limited Liability Company is Harmony Operating, L.L.C., a Florida limited liability company (the "Limited Liability Company").
