ARTICLES OF ORGANIZATION
OF

ARTICLE XIII

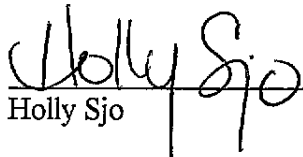
The power to adopt, alter, amend or repeal the regulations of this Limited Liability Company shall be vested in the Manager(s).

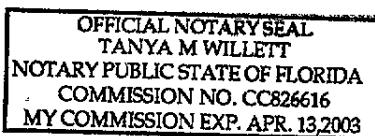

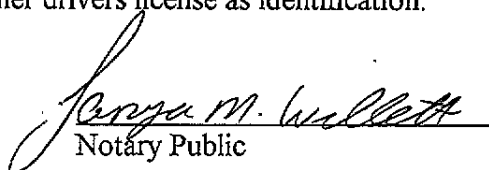

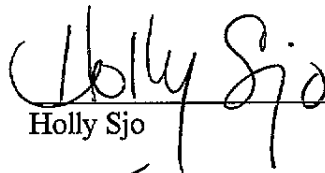
