**ARTICLE I

ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the Company except with the written consent of at least 67% the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the

management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VI TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of at least 67% of the remaining members, provided there are at least two remaining members to continue the business which may include, but not by way of limitation, a sole remaining member and the terminated member's successor(s) in interest if at least one of the consenting terminated member's successors in interest is admitted as a member of the Company as provided above.

ARTICLE VII MANAGEMENT

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 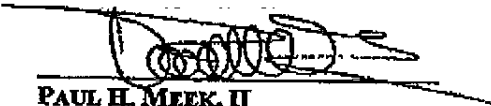

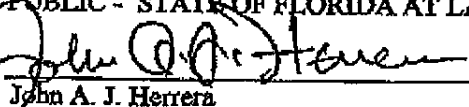
