Pursuant to the provisions of Section 608.441 of the Florida Business Limited Liability Companies Act, the undersigned company adopts the following Articles of Dissolution for the purpose of dissolving GREENBRIAR VILLAGE INVESTMENTS, L.L.C., a company organized under the laws of the State of Florida ("Company"):

1. The name of the Company is GREENBRIAR VILLAGE INVESTMENTS, L.L.C.
2. The Articles of Organization were filed on June 8, 1999 and assigned document number L99000003283.
3. The effective date of the Company's dissolution is October 21, 2008.
