# ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, the by makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME


