1. The undersigned organizers hereby form a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

**ARTICLE I. NAME**

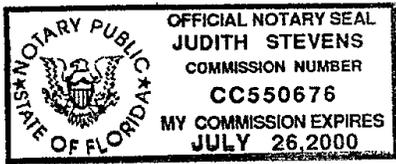

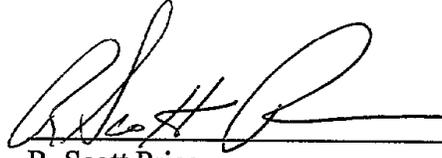

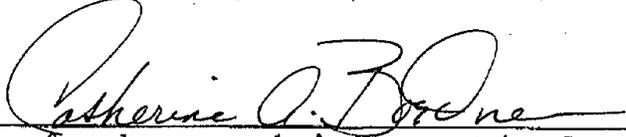
