**ARTICLES OF ORGANIZATION
FOR

4. Management. The Company is to be managed by a manager, whose name and address is:

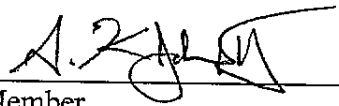

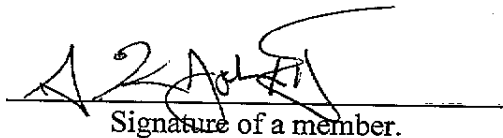
