ARTICLES OF ORGANIZATION OF

ACORR INVESTMENTS, L.L.C

ARTICLE I NAME

The name of this Limited Liability Company shall be Acorr Investments, L.L.C. (the "Company).

ARTICLE II DURATION

The Company shall exist for a period of Thirty (30) years, unless sooner dissolved or extended further in a manner provided by law, or as provided in the regulations adopted by the members (the "Regulations").

ARTICLE III PURPOSE

MANAGEMENT All business of the Company will be conducted under the exclusive management of its members who will vote according to their proportionate interest in the Company and shall have exclusive authority to act for the Company in all matters.

- the death, retirement, or resignation of a member, if the remaining members do (C) not vote unanimously to continue the business of the Company.
