**WHEREAS**, the name of the company is METRO ORLANDO REALTY & INVESTMENTS, L.C., a Florida limited liability company ("Company"); and

**WHEREAS**, the Company was formed pursuant to the laws of the State of Florida on June 10, 1999 and assigned document number L99000003361; and

**WHEREAS**, the Members of the Company have recommended the amendments to the Articles of Organization set forth below; and

**WHEREAS**, the undersigned Company, by and through its Members and pursuant to the provisions of Section 608.411 of the Florida Statutes, unanimously agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth;

**NOW, THEREFORE**, the undersigned hereby amends the Articles as follows:

1. Article "TV" is hereby deleted in its entirety, and the following substituted therefor:

"The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

2. Article "V" is hereby deleted in its entirety, and the following substituted therefor:

"The Company shall be managed by one or more managers as provided in the Company's Operating Agreement."

3. The second sentence of Article "VI" is hereby deleted.

4. Article "VII" is hereby deleted in its entirety, and the following substituted therefor:

"The Company shall not be dissolved upon the death, retirement, resignation, expulsion, or bankruptcy of a Member.

5. The date of the foregoing amendment's adoption was March 24, 2000.

6. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
