**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF ORGANIZATION OF  
BENDER-NPR, LLC**

Pursuant to the provisions of Section 608.411, Florida Statutes, the Articles of Organization of the above-named limited liability company(the "LLC"), filed with the Department of State on the 6th day of June 1999, Charter Number L99000003379, are hereby amended as follows:

1. Paragraph 3 of the Articles of Organization of the LLC is amended (the "Amendment") in its entirety to read as follows:

"The sole purpose for which the Limited Liability Company is organized is to own and manage real property in New Port Richey, Florida, located at 6926 Little Road, New Port Richey, Florida. The Limited Liability Company is prohibited from owning any property other than the property upon which said postal facility is situated, and from engaging in any business other than performing the obligations of a landlord under the terms of any lease relating to the real property. The Limited Liability Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws."

2. Paragraph 4 of the initial Articles of Organization filed on June 6, 1999 remain as is with no change.

3. The aforementioned Amendment to the Articles of Organization was adopted by the Members on the 22nd day of December 1999, pursuant to a special meeting of members convened for this purpose. The members of the LLC unanimously consented to the Amendment and the majority of the members entitled to vote consented to the Amendment.
