ARTICLE I
NAME

The name of this limited liability company is Steve Brown Etc., L.C., referred to in these Articles of Organization as the "Company."

ARTICLE II
MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 539 Versailles Drive, Maitland, Florida 32751.

ARTICLE III
DURATION

The period of duration for the Company shall be perpetual.

ARTICLE IV
MANAGEMENT

The Company is to be managed by a manager. The manager may receive compensation for his services. The name and address of the sole Initial Manager of the Company is as follows:

**ARTICLE VI
ADMISSION OF NEW MEMBERS**

The Company may admit new members by (a) authorization by action of a majority of the units of equity of the Company owned by those existing members entitled to vote on the action and (b) the execution by the new member of the Company's operating agreement.

**ARTICLE VII
MEMBERS' RIGHT TO CONTINUE BUSINESS**

In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company without interruption, and shall continue such business without interruption, unless those remaining members vote to not continue the business of the Company; provided, however that the Company shall terminate upon the death, retirement, resignation, or disability of Rev. Steve Brown.

**ARTICLE VIII
COMMENCEMENT OF CORPORATE EXISTENCE**

In accordance with Section 608.409(1), Florida Statutes, the Company's existence shall be deemed to have commenced at 12:01 a.m. on June 1, 1999, or, if later, at such time and date as is five (5) business days prior to the date on which these Articles of Organization are filed by the Florida Department of State.

**ARTICLE IX
APPLICABLE LAW**

The Company is created pursuant to Chapter 608, Florida Statutes, and shall be governed by the laws of the State of Florida.

**ARTICLE X
AFFIDAVIT OF MEMBERSHIP AND CONTRIBUTIONS**

The undersigned member hereby certifies as follows:

1. The above named Limited Liability Company has at least one member.
2. As of the filing of these Articles of Organization, no cash has been contributed by the members.
3. The agreed value of property or services contributed by the members is \$750,000, and a description of the services being provided is talent, consulting and administrative services.
4. The total amount contributed and anticipated to be contributed by members is One Million Dollars (\$1,000,000.00), which includes 2 and 3 from above.
