#### Name and Duration

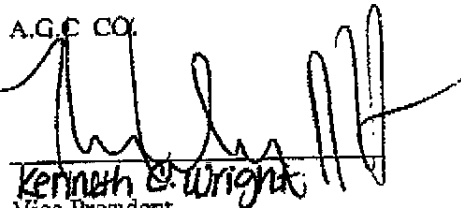
