CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION OF DACRA DESIGN MOORE LLC

The undersigned, being authorized to execute and file this Certificate, hereby amends the Articles of Organization of Dacra Design Moore LLC (the "Company"), as follows:

- (c) The Company shall (i) conduct its own business in its own name; (ii) pay its own liabilities out of its own funds; (iii) observe all limited liability company formalities; (iv) not guarantee or become obligated for the debts of any other entity; and (v) hold itself out as a separate entity.

For the purpose of this Paragraph:

The "Loan" means the loan in the original principal sum of \$10,000,000 to be made by Fremont Investment & Loan to the Partnership, secured by, among other things, a mortgage lien on the Property or interests therein.
