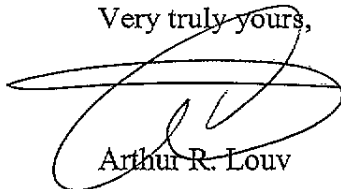

## **ARTICLE VIII – Regulations or Operating Agreement**

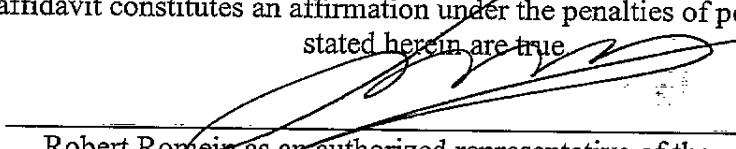
