**ARTICLE I - NAME**

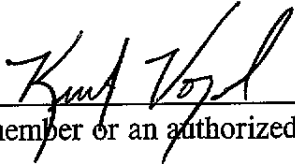
#### **ARTICLE VII - MEMBERS RIGHTS TO CONTINUE BUSINESS**
