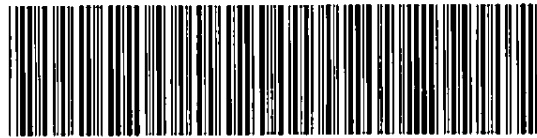

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned does hereby execute and submit for filing with the Florida Department of State these Amended and Restated Articles of Organization of System Soft Technologies LLC (hereafter also as the "Limited Liability Company") as follows:

The Articles of Organization for this Limited Liability Company were filed with Florida Department of State, Division of Corporations, on June 18, 1999 and assigned Florida document number L99000003683.

These Amended and Restated Articles of Organization, which supersede the original Articles of Organization and any amendments thereto, were adopted by all members/managers of the Limited Liability Company on June 07, 2018. To effect the foregoing, the text of the Articles of Organization is hereby restated and amended as herein set forth in full:

**ARTICLE I
