Article I: Name

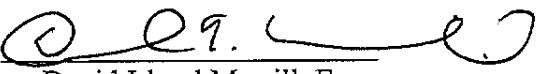

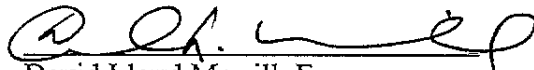
