The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be by unanimous approval of the members in this limited liability company.

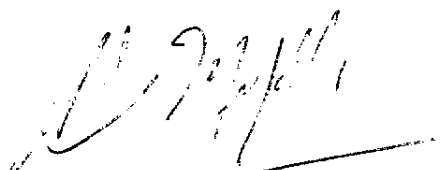
ARTICLE VI
