ARTICLE I - Company Name & SPECIFIC PURPOSE

The term of existence of the Company shall be for a period of thirty (30) years from the filing date of these Articles of Organization with the Department of State.

ARTICLE VII - Members Rights to Continue Business:

The right of the remaining members of the Company to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company is:

The Company may be continued if, within one hundred twenty (120) days after the date of the event which would otherwise result in the termination of the Company, the holders of seventy-five percent (75%) of the outstanding membership interests affirmatively vote to continue the business of the Company.

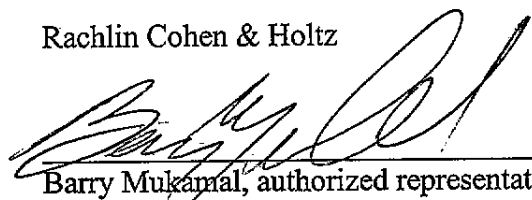
ARTICLE IX - Return of Capital:

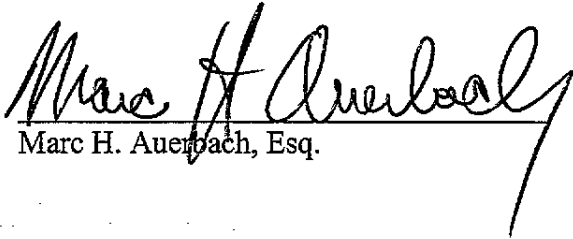

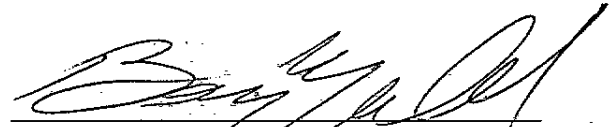
