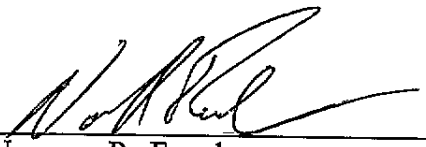
9. Admission of New Members. With the written unanimous consent of the
