The Limited Liability Company's existence shall commence upon the filing of these Articles of Organization with the Florida Department of State.


Article 10. Regulations

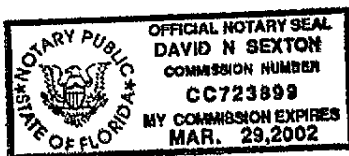
