



The following plan of merger, which was adopted and approved by each party to the merger in accordance with section(s) 607.1107, 614.1103, 608.4381 and/or 620.202, is being submitted in accordance with section(s) 607.1108, 608.438 and/or 620.201, Florida Statutes.



The undersigned, being all the Directors and the sole Shareholder of Second Orlando Area Blimpie Realty, Inc., a Florida corporation (the "Corporation"), hereby consent, pursuant to Sections 607.0821 and 607.0704 of the Florida Business Corporation Act, to the adoption of the following resolutions set forth herein, taking or authorizing the actions specified therein, effective as of the date first written above, and instruct the Secretary of the Corporation to enter this written consent ("Consent") in the minute book of the Corporation:

WHEREAS, the Directors and the sole Shareholder believe it is in the best interest of the Corporation to form a limited liability company under the Florida Limited Liability Company Act for purposes of merging the Corporation into such limited liability company; and




