## ARTICLES OF ORGANIZATION OF NORTHWEST FLORIDA BLIMPIE REALTY NEWCO, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

#### ARTICLE I. NAME

The name of the limited liability company is "Northwest Florida Blimpie Realty Newco, LLC" (the "Company").

#### ARTICLE II. ADDRESS

#### ARTICLE III. DURATION AND CONTINUATION

The Company's existence shall commence with the filing of these Articles of Companization with the Secretary of State, and shall continue perpetually, unless terminated in accordance with the Company's Regulations.

#### ARTICLE IV. REGISTERED AGENT AND OFFICE

The Company designates 9200 South Dadeland Blvd., Suite 508, Miami, FL 33156 as the street address of the initial registered office of the Company and names United Corporate Services, Inc. as the Company's initial registered agent at that address to accept service of process within this state.

#### ARTICLE V. MANAGEMENT

The management of the Company shall be vested in one or more managers who shall be appointed in accordance with the Company's Regulations. Charles Leaness shall act as the initial manager of the Company, having an address at 740 Broadway, 12<sup>th</sup> Floor, New York, New York 10003.

#### ARTICLE VI. ADMISSION OF ADDITIONAL MEMBERS

Additional members may be admitted upon the approval of a majority of the members of the Company in the manner set forth in the Regulations of the Company.

#### ARTICLE VII. MEMBERS' RIGHTS TO CONTINUE BUSINESS

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company will be as provided in the Regulations of the Company.

#### ARTICLE VIII. REGULATIONS

The power to adopt, alter, amend, or repeal the Regulations of the Company shall be vested in the members of the Company.
