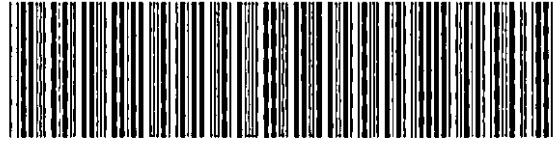

These Amended and Restated Articles of Organization have been duly executed and are being filed in accordance with Section 605.0202 of the Florida Revised Limited Liability Company Act. These Amended and Restated Articles of Organization are intended to amend, restate, and replace the original Articles of Organization in their entirety.

ARTICLE I

Name

The name of the Company is COLONIAL VILLAGE APARTMENTS, LLC.
