**ARTICLES OF ORGANIZATION
OF

The undersigned, for purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I ---NAME

The name of the limited liability company shall be INTERNATIONAL INTERNET MARKETING, L.L.C.

ARTICLE II---ADDRESS

The mailing address and street address of the principal office of the company shall be: 271 S.E. 11th Street, Pompano Beach, Florida 33060.

ARTICLE III---DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV---REGISTERED AGENT AND OFFICE

ARTICLE VI--ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.

ARTICLE VII--ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in these Articles of Organization, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VIII--TRANSFER OF INTEREST

No member may assign, sell, gift, or otherwise make a life time transfer of his or her shares in the limited liability company without the written unanimous consent of all members other than the member who is proposing to assign, sell, gift, or otherwise make a life time transfer.

ARTICLE IX--TERMINATION OF EXISTENCE

The company shall be dissolved on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company.

ARTICLE X--MANAGEMENT

The company shall be managed by the managers in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 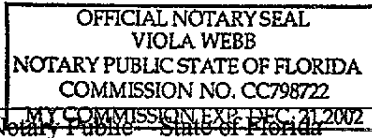
