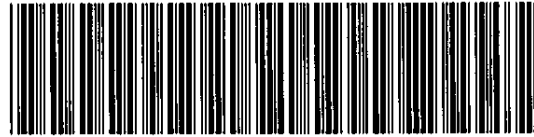

5. All debts, obligations and liabilities of the Company have been paid or discharged or adequate provision has been made therefor as of December 31, 2008.

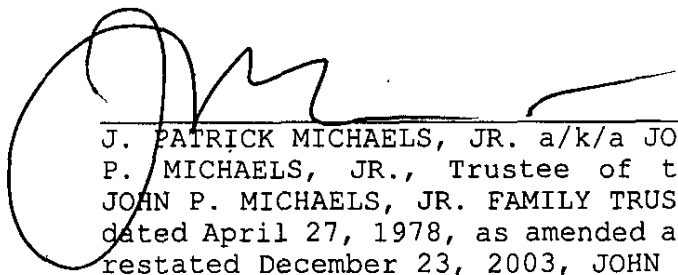
All remaining property and assets of the Company have been liquidated and distributed to its sole Member as of December 31, 2008.
