ARTICLES OF ORGANIZATION OF WATSON'S TOWING  
LIMITED LIABILITY COMPANY

The undersigned, being authorized to execute and file these Articles of Organization, hereby certify that:

**ARTICLE I — Name:**

The name of the limited liability company (hereinafter referred to as the "Company") is **WATSON'S TOWING LLC.**

**ARTICLE II — Address:**

The mailing address and street address of the principal office of the Limited Liability Company is: 1104 South Main Street, Gainesville, FL 32601.

**ARTICLE III — Duration:**

The period of duration for the Limited Liability Company shall be: Perpetual unless the Company is earlier dissolved as provided in these articles of organization.

**ARTICLE IV — Management:**
