### **ARTICLE VII — Limitation on Agency Authority of Members**

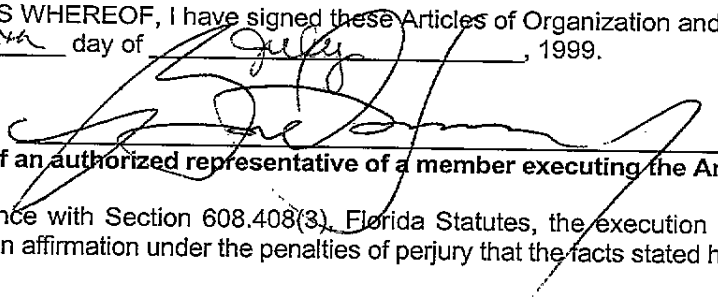
