ARTICLES OF ORGANIZATION

OF

ARTICLE I

NAME

The name of the Limited Liability Company is: PINES ACADEMY,

DURATION AND COMMENCEMENT OF EXISTENCE

ARTICLE VI

ARTICLE VII

DISSOLUTION; WINDING UP; LIQUIDATION

A. Dissolution. The Limited Liability Company shall be dissolved on the happening of any of the following events:

1. Death, insanity, bankruptcy, resignation, retirement or expulsion of any Member.
2. Dissolution of any Member who is an entity.
3. Majority Vote of the Members.
4. When the term of the Limited Liability Company expires.
5. When the Limited Liability Company has fewer than two (2) Members.

B. Right to Continue Business. The remaining Members of the Limited Liability Company shall have the right to continue

the business upon the dissolution of the Limited Liability Company, or occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company. The exercise of this right to continue shall be by Notice by any one or more Member (representing at least a majority of the interests in the Limited Liability Company) to the remaining Members within thirty (30) days after dissolution as described in subsection A. of this Article.

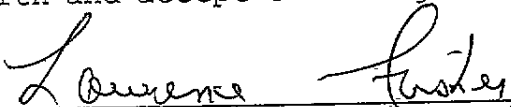

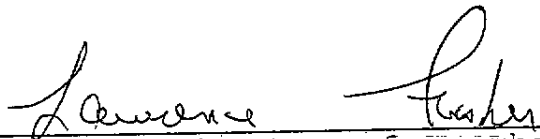
