**ARTICLES OF ORGANIZATION
OF
TRIDENT FLORIDA TRADING LIMITED LIABILITY COMPANY**

The undersigned natural persons, of legal age, acting as members under the provisions of Florida Statutes, Chapter 608, adopts the following Articles of Organization:

ARTICLE I

NAME AND ADDRESS
