#### ARTICLES OF ORGANIZATION FOR BMS AVENTURA, L.L.C., a Florida limited liability company ("Company")

The undersigned, desiring to form a limited liability company under the Florida Limited Liability Company Act, codified as Chapter 608, Florida Statutes, do hereby adopt the following Articles of Organization for such company:

Name. The name of the Company shall be:

- <u>Duration/Continuation</u>. - 5 <u>Voting By Members</u>: As to matters upon which Members of the Company are entitled to vote, each Member's vote shall based upon the Member's percentage interest, in effect from time to time, in the profits and losses of the Company, as set forth in the Company's Regulations.

- 8. <u>Amendment of Regulations</u>. The power to adopt, alter, amend or repeal the Regulations of this Company shall be vested in the Managing Members of the Company.
- 9. <u>Organizing Members</u>. The name and address of the organizing Member executing these Articles of Organization is as follows:

- 10. <u>Amendment of Articles of Organization</u>. Any amendment to these Articles of Organization shall be consistent with Chapter 608, Florida Statutes, and shall be signed and sworn to by one or more Managing Members of the Company. In the event a new Member is added by such amendment, it shall be also signed by the Member to be added.
- 11. Regulations of the Company. The power to adopt, alter, amend or repeal the Regulations of the Company shall be vested in the Managing Members. Regulations adopted by the

Managing Members may be repealed or altered, and new Regulations may be adopted, by the affirmative vote of the Managing Members.

- 12. <u>Informal Action of Members</u>. Any action of the Members may be taken without a meeting if consent in writing setting forth the action taken shall be signed by all Members who would be entitled to vote upon such action at a meeting (and filed with the Company as part of its records).
- 13. <u>Contracting Debt.</u> Except as otherwise provided by applicable law, no debt shall be contracted nor liability incurred by or on behalf of this Company, except by the Managing Members.
- Transferability of Member's Interest. The interest of a Member of this Company may not be transferred or assigned except to such extent and in the manner provided in the Regulations. However, unless all of the Managing Members of this Company approve of such proposed transfer or assignment, the transferee of the interest of such Member shall have no right to participate in the management of the business and affairs of this Company or to become a Member. In such event, the transferee shall be entitled to receive only the share of profits or other compensation or distributions, and the return of contributions, to which that Member otherwise would be entitled.

## 15. Withdrawal or Reduction of Member's Contributions to Capital.

- (a) A Member shall not receive out of the Company's property any part of such Member's contribution to capital until:
- (1) all liabilities of the Company, except liabilities to Members on account of their contributions to capital, have been paid or sufficient property of the Company remains to pay them; and
- (2) the consent of all Members is had (unless the return of the contributions to capital may be rightfully demanded); and
- (3) these Articles of Organization are canceled or so amended as to set out the withdrawal permitted.
- (b) A Member shall be entitled to the return of the Member's contribution in the manner, if any, provided for in the Regulations of the Company.
