ARTICLES OF ORGANIZATION FOR THE LIMITED LIABILITY COMPANY OF PRICE RENT-A-CAR, L.C.

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby form a Florida limited liability company (this "Company") pursuant to the Act and hereby set forth the following Articles of Organization (these "Articles"):

ARTICLE I NAME

The name of this Company shall be:

ARTICLE II COMMENCEMENT DATE AND DURATION

This Company shall commence on the date of the filing of the Articles of Organization in accordance with the provisions of Section 608.409(3) of the Act. The period of duration for the Company shall be perpetual.

ARTICLE III PURPOSES

This Company is created and formed for the purpose of engaging in all lawful businesses authorized for a Company pursuant to Section 608.403 of the Act.

ARTICLE IV PLACE OF BUSINESS

The principal place of business of this Company shall be 9251 South Orange Blossom Trail, Orlando, Florida 32387 and such other place or places as may be designated by the members from time to time. The members are hereby authorized and directed to prepare and adopt an Operating Agreement and Regulations for the governing of the internal affairs of this Company containing such provisions as they consider necessary, reasonable or desirable, except that no provisions of such Operating Agreement and Regulations may conflict with the provisions of these Articles of Organization, unless otherwise permitted herein. The power to adopt, alter, amend or repeal the Operating Agreement and Regulations shall be set forth in the Operating Agreement and Regulations, except that the initial form shall be approved by all the members.
