**ARTICLES OF ORGANIZATION
OF
SNA AVIATION, L.L.C.**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following.

1. Name. The name of the Limited Liability Company is **SNA AVIATION, L.L.C.**

2. Period of Duration. The period of duration of the Limited Liability Company shall be from the date of filing until the first to occur of the following:

(i) Thirty (30) years from the date of filing of these Articles of Organization with the Department of State, or

(ii) Dissolution of the Limited Liability Company pursuant to provisions of the Florida Limited Liability Company Act and the Limited Liability Company Agreement for **SNA AVIATION, L.L.C.**

3. Purpose. The purpose for which the Limited Liability Company is organized is to acquire, own, lease, operate, and otherwise invest in, and deal with, aircraft, and to engage in any other activities related or incidental thereto.

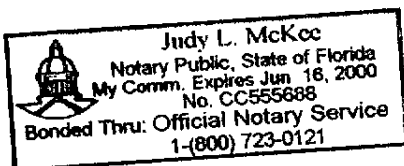




