**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a Limited Liability Company under Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of this Limited Liability Company is: **JAXSON 7, LLC.**

**ARTICLE II  
ADDRESS**

The mailing address and street address of the principal office of the Limited Liability Company is 6850 Belfort Oaks Place, Jacksonville, FL 32216. 


