**ARTICLES OF ORGANIZATION  
OF  
e self develop.com, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I**

Name. The name of the limited liability company shall be "e self develop.com, LLC" ("Company").

**ARTICLE II**

Address. The mailing address and street address of the principal office of the Company shall be 951 Cottontail Lane, Maitland, FL 32751.

**ARTICLE III**

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in regulations of the Company.

**ARTICLE IV**

**ARTICLE V**

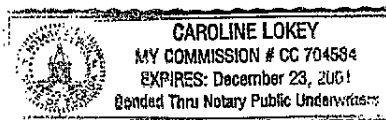
