ARTICLES OF ORGANIZATION

OF

PENSION SERVICES 2000, LLC


The undersigned, as the authorized representative of Pension Services 2000, LLC (the "Company"), deposes and says:

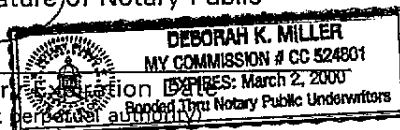
