**ARTICLES OF ORGANIZATION
OF
WEBSCAPE ASSOCIATES, LLC**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Webscape Associates, LLC

SECOND: The latest date on which the Limited Liability Company is to dissolve is December 31, 2050.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes Annotated Sections 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Florida is 17600 N.E. 7th Avenue, North Miami Beach, Florida 33162, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Maximo Smolarcik.

FIFTH: The mailing address and principal office of the Limited Liability Company is 17600 N.E. 7th Avenue, North Miami Beach, Florida 33162.

SIXTH: The Limited Liability Company is to be managed by two Managing Members. The names and addresses of the initial Managing Members are: Maximo Smolarcik, having an address at 17600 N.E. 7th Avenue, North Miami Beach, Florida 33162 and LK Investment Co., LLC, a Michigan Limited Liability Co., having an address at 25501 Colleen Street, Oak Park, MI 48237.

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Members is \$125,000.00. Each of the Members contributed the amount set forth below:

LK Investment Co., LLC, a Michigan Limited Liability Co. -- \$10,000.00 now
and \$115,000.00 within six months.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as may hereafter may be agreed by the unanimous vote of the Members. No additional capital contributions have been agreed to by the Members at this time.

TENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members.




THIRTEENTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.




