**ARTICLES OF ORGANIZATION OF  
TOTAL VASCULAR CARE, P.L.**

Pensacola Radiology Consultants, P.A., a Florida professional association, and entity competent to contract, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**

The name of this limited liability company is:

TOTAL VASCULAR CARE, P.L.

This limited liability company is referred to in these articles as "the Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing address and street address of the principal office of the Company is 5150 Bayou Boulevard, Suite 2-A, Pensacola, Florida 32503.

**ARTICLE III - PURPOSES AND POWERS**

The Company is organized for any legal and lawful purpose for which a professional limited liability company may be organized and may exercise all powers and rights which a professional limited liability company may exercise under the Florida Limited Liability Company Act.

**ARTICLE IV - TERM OF EXISTENCE**

The Company shall have a perpetual existence unless the Company is terminated as provided in its regulations or operating agreement. Provided, however, if the Company has more than one member, then upon dissociation of a member the remaining members

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

The address of the initial registered office of the Company shall be 5150 Bayou Boulevard, Suite 2-A, Pensacola, Florida 32503, and the name of the initial registered agent of the Company at that address is Karl E. Weingarten, M.D.

**ARTICLE VI - MANAGEMENT**

The Company will be managed by its members. The name and address of the entity that is the initial member and that will manage the Company in accordance with the regulations or operating agreement of the Company are as follows:

**ARTICLE VIII - MEMBERS RIGHT TO CONTINUE BUSINESS**

Upon the bankruptcy, dissolution, death or withdrawal from the Company of a member, the remaining member or members of the Company shall have the right to continue the business of this limited liability company.

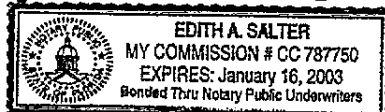
