CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION OF DARGREENE INVESTMENTS, LLC

FIRST:

The date of filing of the Articles of Organization was August 4, 1999.

SECOND:

The following amendment to the Articles of Organization was adopted by the

limited liability company on August 10, 1999:

ARTICLE VII, MEMBERS AND CONTRIBUTIONS, is hereby amended to state the following (substitute this paragraph for the one originally stated):

Ownership interest in the LLC is vested in its two initial members as stated herein. Colin Phoenix Investments, Inc., shall make an initial contribution of \$39,200.00 and shall own a 49% interest in the LLC. The Dardenne Living Trust, dated May 4, 1999, shall make an initial contribution of \$40,800.00 and shall own a 51% interest in the LLC. The members have not agreed to make any additional contributions, but may agree to do so in the future upon the terms and/conditions set forth in the Operating Agreement of the LLC.
