**ARTICLES OF ORGANIZATION
OF
CFO BUSINESS PARTNERS, L.L.C.**

The undersigned, authorized representatives of the member of CFO Business Partners, L.L.C., under the Florida Limited Liability Company Act, adopt the following Articles of Organization.

ARTICLE I - NAME

ARTICLE VI - CONTINUATION OF BUSINESS UPON TERMINATION OF MEMBER


