The organizer of Trawick Holdings, LLC is James L. Trawick, 1555 South Boulevard, Chipley, Florida, 32428.


**ARTICLE III

The registered agent of the Company shall be James L. Trawick. The office of the registered agent shall be 1555 South Boulevard, Chipley, Florida, 32428.


