ARTICLES OF ORGANIZATION
OF
ANKH INVESTMENTS OF FLORIDA, L.L.C.

ARTICLE I

Name. The name of this organization shall be ANKH INVESTMENTS OF FLORIDA, L.L.C.

ARTICLE II

Duration. The Limited Liability Company shall be perpetual.

ARTICLE III

Address. The mailing address and street address of the initial principal office of the organization shall be:

6624 Gateway Avenue, Sarasota, Florida 34231

ARTICLE IV

Registered Office and Registered Agent. The street address of the initial registered office shall be 6624 Gateway Avenue, Sarasota, Florida 34231 and the registered agent at such address shall be KURT F LEWIS.

ARTICLE V

Membership. The initial membership shall be two members:

Additional members shall be admitted by a concurrence of the two initial members and an investment equal to the initial investment made by both initial members.

ARTICLE VI

Death, Retirement, Resignation, Expulsion, Bankruptcy or Dissolution of a member. In the event a member dies, retires, resigns or is expelled from the organization, the surviving members may, at their option, continue with the business. The value of the member's share at the time of their nonparticipation for any reason shall be paid by the organization to the member or any other such person as the member directs in writing. In the event of Bankruptcy or Reorganization of a member, the organization shall have an immediate right to purchase the interest of the member filing bankruptcy at the then fair market value of their interest.

ARTICLE VII

Management. This organization shall have one manager initially. The number of managers, who shall be selected solely from the members, may be either increased or diminished from time to time by the members, but shall never be less than one. The name and address of the initial manager signing these organizational papers is:

ARTICLE VIII

Initial Capital. The initial capital utilized to form this Limited Liability Company is One Thousand Dollars in cash received from the initial managing member. With two initial members, the initial total capitalization shall be Two Thousand Dollars. The capital contribution of each future member shall be no less than One thousand dollars or such amount as shall be from time to time set.

ARTICLE IX

Bylaws. The organization shall have the power to adopt, alter, amend or repeal bylaws which shall govern the operation of the business. The right to adopt bylaws shall be vested in the members.

ARTICLE X

Amendment. This organization reserves the right to amend or repeal any provisions contained in these articles of organization, or any amendment hereto, and any right conferred upon the members is subject to this reservation.

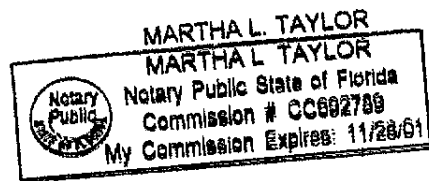

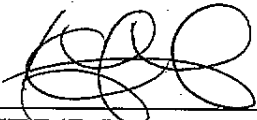

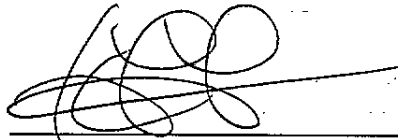
