ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is SOUTHGATE LIMITED, L.@ "Company").

ARTICLE II. ADDRESS

ARTICLE III. DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and Shall continue perpetually, unless terminated (I) in accordance with the Company's Regulations, (ii) by the unanimous written agreement of all Members, (iii) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or (iv) upon the occurrence of any other event which terminates the continued membership of a Member. ARTICLE IV. PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V. REGISTERED AGENT AND OFFICE

The Company designates 1803 South Australian Avenue, Suite A (LWH), West Palm Beach, Florida 33409 as the street address of the initial registered office of the Company and names Larry W. Hodges as the Company's initial registered agent at that address accept service of process within this state.

ARTICLE VI. ADDITIONAL MEMBERS
